VENDOR RULES & AGREEMENT

- 1.Nanaimo Blues Society will determine booth selection and set up location of booths.
- 2.Hours of operation: Thursday, August 23rd 8:00 pm to Sunday August 26th 9:00 pm
- 3.**\$100 NON-REFUNDABLE** deposit by June 30th to reserve your space. Balance due prior to set-up of the day of the event August 23, 2018. (110.00 including GST Plus \$100 damage deposit). Mail to Box 306, Nanaimo, V9R 5L3.
- 4.\$100 damage deposit is refundable upon cleanup & an inspection for any site damage. (i.e., oil leaks, damaged trees, broken bricks etc.)
- 5.**All vendors must provide proof of liability insurance, Vancouver Island Health Authority certificate and BC Safety Authority approval prior to setup.**
- 6.All extension cords to be of heavy duty type and tagged with vendors name. These shall be installed as to avoid tripping hazards.
- 7.Security will be on site overnight, however the Nanaimo Blues Society will not be responsible for damage that is beyond our control.
- 8.Vehicles for towing your equipment are not to remain on site during operating hours.
- 9.In order to maintain the integrity of this agreement I will only sell foods that have been pre-approved by Darlene Kelt and/or the Nanaimo Blues Society and not duplicate other vendor’s menus.
- 10.I understand that the Nanaimo Blues Society has no control over the vendor licensed by the City of Nanaimo to operate at Maffeo-Sutton Park.

I have read, understand and will comply with the rules listed above. Further, we hereby assume all responsibility and will not hold the Nanaimo Blues Society or its Directors or Associates liable for any and all injuries, damages or mishaps direct or consequential that may occur during our participation in this event.
